UNCONDITIONAL TAKE-OVER OFFER BY AMINVESTMENT BANK BERHAD ("AMINVESTMENT BANK") ON BEHALF OF FREEWAY TEAM SDN BHD, CHIANG SANG SEM AND CHIANG FONG YEE (COLLECTIVELY THE "JOINT OFFERORS") TO ACQUIRE ALL THE REMAINING ORDINARY SHARES OF RM0.50 EACH IN BONIA ("BONIA SHARE(S)") NOT ALREADY HELD BY THE JOINT OFFERORS AND THE PERSONS ACTING IN CONCERT WITH THEM ("OFFER SHARE(S)") FOR A CASH CONSIDERATION OF RM2.04 PER OFFER SHARE ("OFFER")

We refer to the notice and supplemental notice of the unconditional take-over offer dated 28 August 2012 and 29 August 2012 respectively, served on the Board of Directors of Bonia by AmInvestment Bank on behalf of the Joint Offerors.

On behalf of the Joint Offerors, AmInvestment Bank wishes to inform you that the offer document dated 18 September 2012 which sets out the details of the Offer together with the Form of Acceptance and Transfer ("Offer Document") have been despatched today to the Board of Directors and shareholders of Bonia whose names appear in the Record of Depositors of Bonia and having a registered Malaysian address.

Further, on behalf of the Joint Offerors, AmInvestment Bank also wishes to inform that the Equity Compliance Unit of the Securities Commission had, vide its letter dated 14 September 2012, taken note of the possible changes to Bonia's equity structure resulting from the Offer. In the event that Bonia remains listed upon the completion of the Offer and is required to comply with the public shareholding spread requirement, AmInvestment Bank / Bonia is required to submit the following:-

- (i) list of acceptances for each category of shareholders in Bonia; and
- (ii) effective equity shareholding structure of Bonia before and after the Offer,

wherein equity condition may be imposed if the Bumiputera equity is reduced below 12.5% after the Offer.
